3. TERMS OF BUSINESS:

- 3.1 Balance of agreement to be paid in full on day of departure.
- 3.2 Wounded animals must be paid for in full.
- 3.3 Payment: strictly cash, traveler's cheques or bank guaranteed cheques.
- 3.4 No refunds for cancellations. The Outfitter is willing to schedule alternative hunting dates within the same year that are mutually acceptable. If mutually accepted hunting dates cannot be agreed upon

a \$250 penalty fee will be added to the original agreement in order to carry the hunt over to the next year.

3.5 The Client undertakes herewith to give his/her full cooperation to the rules and regulations set by the Outfitter regarding weapon safety and ethical hunting methods.

3.6 Package Hunts:

3.7 Should a client be unable to bag an animal/s in his/her package, the animal will be carried over to the next hunt regardless of when.

3.8 Indemnity:

Hunting is a potentially dangerous sport and while the Outfitter and his staff are well qualified and experienced, the Parties agree herewith that neither the Outfitter nor his staff will be held responsible by the client for any accident happening on Safari. The client undertakes herewith to take out all risk insurance before the hunt commence and at all times hunt at own risk.
